7. **VALIDITY:-**The tendering firms are required to keep their offer open for 90 Days from the date of opening of the bid. In order to give full effect to the provisions of this guarantee the Bank thereof waives all rights inconsistent with the above provisions and which the Bank might otherwise as a guarantee be entitled to claim and enforce.
